

Purpose: The ICON award was created in 2018 to recognize an individual or group that has a proven track record in heightening the awareness of WAMSS and elevating the esteem of the medical services professional.

Eligibility: Nominees may be individuals or groups, members of WAMSS or key stakeholders. Nominees must have working knowledge of the value and scope of services provided by medical services professionals as well as the strategic goals of WAMSS. Nominees must have a proven track record in heightening awareness of WAMSS and elevating the esteem of the medical Services professional. The deadline for nomination is January 15th of each calendar year.

Criteria for Nomination:

- > Continuous encouragement and enthusiasm for the work of the Washington Association Medical Staff Services.
- > Commitment to the organizational goals, mission and vision of the Washington Association Medical Staff Services.
- > Demonstrated success in heightening awareness of WAMSS to members, employers, key stakeholders and/or the public.
- > Demonstrated success in promoting the value of the medical services professional's role to the healthcare community.
- > Demonstrated success in elevating the esteem of the medical services profession.
- > Qualities of leadership and statesmanship exhibited for the benefit of the organization and the profession.

Decision Process:

The WAMSS Scholarship Committee Chair will gather the materials and send the information to its Committee members. ** The materials will include a copy of the ICON Award scoring tool. The Committee will verify the nominee's eligibility for the award, then evaluate the various professional accomplishments **If there is only one(1) nomination for the ICON Award then the WAMSS Scholarship Committee Chair will forward the single nomination on to the Board without the Committee's review/score.

The WAMSS Scholarship Committee Chair will add the points scored for each candidate. As with other committees, the Chair will not vote unless there is a tie.

The WAMSS Scholarship Committee Chair will forward all nominees to the WAMSS Board in a written report by February 15th, prior to the annual meeting. The format for this recommendation is as follows:

The WAMSS Scholarship Committee hereby recommend to the WAMSS Board of Directors (Board) that (name) be awarded the (indicate year) ICON Award (based on total score). Additional nominees considered for this award are included in this notice.

The Board will review the materials, including the completed scoring tools, and the Committee's recommendation. The Board will vote and decide the recipient of the ICON Award.
